## ...From LAURA'S DESK



**Greetings!** I want to say thanks to all who have worked so hard this year – the Board of Directors, as well as the help and support of our very active members – as we wrap up a successful 2016-17.

On April 23, we celebrated our work in the educational community by awarding seven “camperships” to **Tech Trek** seventh graders and five **Scholarships** to worthy young graduating seniors for their volunteer work and exemplary leadership. Last month our STEM Project Committee put on the second **EYH-STEM Conference** at **Saint Mary's College**. Through their efforts we brought together over 100 people from our membership, local high schools, colleges and the community to present a day long conference for 150 plus middle school girls including 16 through outreach efforts to underserved schools outside Lamorinda. Over 20 volunteers continue to provide tutors, teacher aides and library helpers to **Burckhalter Elementary School** in Oakland. And, through the work of our programs and advocacy committees, we brought some very impressive presenters to our general meetings to share their stories and knowledge on important issues of the day. When you think about the number of lives we touch with these activities it is pretty impressive. We are making a difference in the lives of women and girls in amazing ways. Take a bow and give each other a pat on the back for a job well done!

**Here are a few important items to pay attention to and vote on:**

**Revision of OML Bylaws** The committee to revise the bylaws – headed by **Denise Burian** – has done a great job bringing our bylaws into compliance with the nonprofit status required by AAUW National for State and Federal Tax Codes. You will be asked to vote at the May luncheon meeting to approve these revisions of our branch 501 (c)(4) bylaws. We also had to revise our bylaws for the 501(c)(3) Community Outreach, which does not require a vote of the membership. You can review the proposed revised bylaws on our website.

**AAUW National Officers Vote** There are some changes to the national bylaws including qualification for membership – a continuing issue for AAUW on the national level. At the AAUW-CA meeting recently, I gained a new perspective on why we might want to allow non-degreed individuals to join AAUW. Many adults who honor our mission and goals may not have had the opportunity to get a degree, which does not mean they do not value the importance of the AAUW mission regarding equality for all women and girls. This poses the question: If we deny them membership are we not denying them equality of status? Furthermore, we already accept male members. Also, admitting non-college graduate would not require a name change. As an example, the NAACP did not change its name when it began admitting white individuals. You will be receiving emails requesting you to go on the National website and vote on this issue as well as to elect new officers. Voting is a right and a privilege – remember to take the time to cast your ballot. Help make a difference in how the world sees us as members of AAUW.

See you at the May luncheon for the installation of officers and celebration of this year's Distinguished Woman, **Mary Ann McLeod**, and of her life as a woman, mother, wife, teacher, friend and member of OML. *Congratulations, Mary Ann.*

## BOARD MEETING HIGHLIGHTS APRIL 11, 2017

**The 501(c)(4) Meeting:**

A possible Leadership Day, led by members of the state AAUW, was discussed. Possible dates offered were in July: 13, 26, or 27. The motion to further develop this program was passed.

Funds allocated to cover the awards event on April 23 was discussed.

Further clarification was discussed concerning the bylaws changes that would eliminate the hospitality chair as voting member of the board.

A motion to continue support of the National Start Smart program offered at local colleges was made and passed.

**501(c)(3) Outreach Meeting:**

The addition of chairs of the outreach priorities to the 501(c)(3) board and eliminate the membership chair was discussed. These recommendations will be voted upon at the May 9th board meeting.

A motion was made, discussed and passed to add \$290 to the Tech Trek budget in order to reserve the Shred Fest truck for our fundraiser in October, 2017. Jan Cushman will hold a yard sale at her home, Saturday, May 20, from 9 am to 3 pm to benefit Tech Trek.

The next EYH-STEM Conference will take place in the Soda Center at Saint Mary's College, Saturday March 17, 2018.

The Oakland Unified School District has cut funding for the 2017-2018 school year. Burckhalter will likely call on OML to support its library efforts.

## Focus on ... CELEBRATION of EXCELLENCE

### Twelve Incredible Young Women Receive AAUW-OML Scholarship Awards

On Sunday, April 23, our branch presented 12 outstanding young Lamorinda women with Tech Trek camp and college scholarships.

#### Tech Trek Camp Scholarships

To encourage young women to pursue STEM (science, technology, engineering and math) careers, where women are currently underrepresented, AAUW-OML sends middle school girls interested in science and math to **Tech Trek Camp**. The seven 2017 Tech Trek scholarship winners are **Olivia House** and **Cathy Kenderski** from Joaquin Moraga Intermediate, **Kiara Kofoed** and **Katerina Bonderud** from Orinda Intermediate, and **Namratha Kasalanati**, **Isabelle Lurie**, and **Maia West** from Stanley Intermediate. Both Olivia House and Kiara Kofoed have older sisters who were awarded scholarships to Tech Trek camp in 2015.



These Tech Trek scholarship winners (*in photo above*) impressed the April Awards Ceremony attendees with presentations describing their love of science and math and their future goals – and these girls do have lofty ones! Kiara Kofoed has a strong interest in computers and robotics. She hopes to apply her knowledge to have a global impact in the political arena. Katerina Bonderud is inquisitive and creative with an interest in robotics and engineering. Olivia House, who loves outer space and music, hopes to be a space roboticist. Kathy Kenderski considers herself to be a scientist already, with plans to become an astrophysicist and a science journalist. Isabelle Lurie makes things using a 3D printer in her Girls Maker Club and has started a Science Bowl at her school. Maia West is enthusiastic about many STEM fields, including physics, astronomy, engineering, robotics and problem solving. Namratha Kasalanati, who is an athlete and musician, has a strong interest in combining scientific knowledge and public policy.

These girls want to make this world a better place. They were chosen after a rigorous process of being nominated by their teachers, completing an application, and being interviewed by a team of three AAUW-OML members. Two intermediate school teachers attended the award ceremony to honor the seven scholarship winners.

### DR. KRISTEN BECK Keynote Speaker



Dr. Beck, Professor of Mathematics at Saint Mary's College in Moraga, inspired the scholarship winners and their families with her passion for mathematics. By providing a fascinating presentation on fractals that involved beautiful geometric shapes, many of which are found in nature. Kristen described how she was not encouraged by her family to attend college, but was motivated by her love of learning. She also explained trying several majors before finding one that fit her interests and passions, and advised the young women to rely on their own instincts and follow their own path when making a career choice. Dr. Beck earned her Ph.D. at the University of Texas and conducts leading edge research in commutative and homological algebra.

### High School and College Scholarships

The goals of AAUW's high school and college scholarships are to encourage local young women graduates who demonstrate academic excellence and weave a commitment to community service and leadership into their lives. The average GPA for the fourteen finalists was 4.0. The five awardees described their stories of growth and life lessons learned through community service and leadership activities at the AAUW-OML annual celebration.



The 2017 \$1,000 AAUW-OML scholarships were awarded to **Blake Sharp** (Miramonte High School) and **Cara Wolfe** (Acalanes High School). A \$5,000 Gail Uilkema Scholarship was awarded to **Zoe Portnoff** (Campolindo). **Valeria Martin**, a senior at Saint Mary's College, was given a \$2,000 Leadership Award. **Annie Dao**, also a senior at Saint Mary's, was given a \$5,000 Gail Uilkema Scholarship.

The awardees (*pictured in photo above*) participated in programs that benefited their school community such as academic decathlon, school band, judicial tribunals, and athletic teams. Urban Farmers, Tony Larussa's Animal Foundation and John Muir Hospital are examples of programs to which they contributed countless hours. The awardees also embraced the global community by raising funds locally to endow international ecology and education programs. They also volunteered in Mexico, Vietnam, Brazil and Peru.

## PUBLIC POLICY

### Take Action! Let your voice be heard!

Many of you receive emails from AAUW about taking action on potential legislation or votes being taken in Congress or in our state legislature ... and we hope you read them AND respond! This is an easy and excellent way to stay connected and to express your opinion. Even when you think that you already know how our senators, representatives and state legislators will vote ... it is STILL important to have your voice counted. Those men and women who represent us at the state and national levels will tell you that their offices track the responses that we all send to them. Your response is an important barometer of opinion and it IS being counted. Make sure that your opinion is heard!

Achieving pay equity for women is multi-faceted. It includes supporting paid leave and banning prior salary history in hiring. A bill set to be voted on in Congress this week would reduce paychecks for women working overtime.

### AAUW urges you to take action now:

#### **Oppose the Working Families Flexibility Act.**

The House of Representatives is poised to consider the deceptively-named Working Families Flexibility Act (H.R. 1180), which would erode longstanding overtime protections and create a "comp time" law that would offer a false choice between time off and money in their paychecks.

AAUW is committed to greater availability of and access to a high standard of benefits and policies that promote work-life balance, which are critical to achieve economic self-sufficiency for all women. The misnamed Working Families Flexibility Act is not an improvement for working families.

**Take action now and urge your representative to oppose the Working Families Flexibility Act (H.R. 1180)!**

## MEMBERSHIP

### How to Pay Your Dues:

The yearly member profile and dues form will be mailed on May 10. This year we are asking that **everyone complete and return the profile form even if you don't owe any dues or you are paying online.** A return envelope will be included. The form has been slightly revised from prior years so please don't just say, "everything the same." For most of you, your membership expires on June 30. Please pay dues promptly by mailing a check or paying online before June 30. There are two ways to pay online if you don't want to mail a check:

### For the Less Tech Savvy:

If you haven't set up online access with AAUW National and you don't want to go through the steps to do so, or you hate doing things online but still want to pay with a credit card, email **Gail Chesler** at [gailchesler@gmail.com](mailto:gailchesler@gmail.com) and ask that she send you an email link. It's quick, easy and a painless way to pay. **But please mail in the profile form if you pay online.**

### For many of you:

It's not that complicated and you can certainly figure out online payment yourself. If you don't mind a little clicking around and want to pay online by yourself, you can do it by going to [aauw.org](http://aauw.org) using Google or whatever search engine you want. Here's how to do it:

- 1) At the top of the website in a grey bar is the word 'login'. Click on that.
  - If you have registered before, I hope you checked the box "remember me" and then you don't have to remember your member ID or password, just click log-in.
  - If you are a first time user you will need to create an account. You must use your member ID and make up a password. Your member ID is on the membership card sticker on the front of your directory, unless you are a new member. It is also on the back of the AAUW Outlook magazine you recently received.
  - Don't have it? Can't find it? Email Gail Chesler at the above email address or Alison Mackenzie at [alimac2020@gmail.com](mailto:alimac2020@gmail.com).
- 2) After you set up an account, click on 'login'.
- 3) After you have logged in, scroll down the page near the bottom left and look for Member Services Database (MSD). Click on it.
- 4) Click on the green bar 'Enter the MSD'.
- 5) Then click again on the next screen 'Enter Member Services Database' in the little box. (No, I don't know why they make it seem like you're entering Ft. Knox.)

Anyway, that should do it and you should then see your own member info. On the left hand side in the box, look for 'Renew My Membership'. That will take you to the screen to enter your credit card information.

## The 2017 DISTINGUISHED WOMAN, Part 2

AAUW-OML is proud to recognize Mary Ann McLeod as the Distinguished Woman of the Year for 2017. She is a person who presents groundbreaking ideas and follows through with action, resulting in a powerful impact on all that she undertakes. Education is the tool that she has used for more than 50 years in helping others grow and enrich their lives – grow and blossom. For many she is an inspirational role model.



As owner/director of Mulberry Tree Preschool in Moraga from 1982 to 2011, Mary Ann created an environment allowing each child to develop according to his or her own unique pattern of growth. She found it rewarding to get reacquainted with some of the same girls she taught as preschoolers when they participated in the Sister-to-Sister program as middle school and high school students. Now she chairs the scholarship committee and finds herself interviewing some of these same students who are graduating from high school and applying for scholarships.

Mary Ann has been an active OML participant, making a notable difference in all areas of her volunteer work with AAUW. She has hosted meetings, served on hospitality, been an interest group leader for Evening Books, a volunteer at the Burckhalter School library, enjoyed Museum Mavens, and was a member of the original Sister-to-Sister committee serving as treasurer and co-chair. She notes that “AAUW was a place where I could grow as a person.”

In the early 1990s Mary Ann joined Saint Mary’s College Professor Tory Courtney in presenting a training workshop for faculty and staff to help them instruct soon-to-be credentialed teachers. The topic was “Sexual Harassment in the Workplace.” In 1999 she received the esteemed OML Gender Equity Award presented by the Educational Equity Committee to an outstanding community educator. The award recognized her leadership for an innovative “team approach” with staff promoting early childhood gender fairness in education. She has long been one of the pillars of our branch. The “foundations for life” that she advocates are repeatedly seen in her own volunteer work. She listens, she builds and she takes charge! Gardening is her hobby and she helps others grow and blossom.

Mary Ann attended Holy Names School for girls and values her Catholic education by Christian Brothers and Sisters – a traditional course of study which helped her immigrant family become part of American society. “Education was a top priority in our family.” She learned a value structure with respect for education, and for right and wrong. Always a good student, she says simply, “I loved school!” She developed a work ethic influenced by her working mother. She graduated from California State University, Fresno with a degree in American History in 1965, and later completed a M.Ed. in Early Childhood Education at Saint Mary’s College. Mary Ann met her husband, Bill, while he was a student at Saint Mary’s College and they married there in the chapel. As parents they are very proud of their two children, Monica and Matt, now adults themselves, and four wonderful grandchildren.

**BYLAWS UPDATE**

**501(3)(4) Operating Fund Bylaws Revision**

National and State AAUW is requiring all branches (affiliates) to amend our by-laws to comply with new legal language that governs non-profits. Our branch convened a bylaws committee to review and develop revised bylaws that comply with National/State requirements and our current bylaws. While the order of the articles and sections within the bylaws document are switched around, the revisions as a whole are not substantive in meaning. Laura convened a committee that has been meeting for about three months. The committee made the required changes and took the opportunity to update our bylaws as follows:

- 1) Changed nominating committee to four members, two elected by membership by November, and two nominated from the board. (Article IX, Section 1a)
- 2) Removed Sister-to-Sister, added STEM Conference chair to the board of directors to reflect current priorities. (Article X, Section 1b)
- 3) Each officer/co-officer has a full vote (our co-chairs have been sharing a vote, but going forward, each will have a vote per CA law). (Article X. Section 1f)
- 4) State requires us to declare a minimum/maximum number of board members, so we added a minimum of 13 and a maximum of 21 appointed and elected positions. (Article XI. Section 1)
- 5) Board meetings will require 40 percent of members present for a quorum for board votes. (Article XI. Section 5)
- 6) Increased the amount of indebtedness (expenses) over a budget amount from \$100 to \$200. (Article XIV. Section 2)

We will vote on the bylaws at our May 23rd membership meeting (which is also our luncheon) as well as vote on the 2017-2018 board of directors. The committee is also in the process of revising the the AAUW-OML Community Projects Fund Bylaws 501(c)(3). Contact **Denise Burian**, or any committee member, with questions. 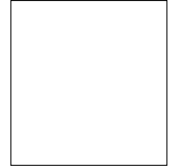
