

#### 2013 AAUW CALIFORNIA LAF LUNCHEON

AAUW-OML members Deana Vick Davidson, Diane Bell-Rettger, Caroline Wood, Jo Harberson and Gloria Weston attended the annual Legal Advocacy Luncheon held in Burlingame March 16. The guest speaker was Jennifer Reisch, an attorney who is the Legal Director for Equal Rights Advocates in San Francisco. She also represents Betty Dukes and the women of Wal-Mart in the Dukes vs. Wal-Mart lawsuit which AAUW is supporting through its Legal Advocacy Fund. Ms. Reisch reported the lawsuit was continuing and they were filing a new motion in April in San Francisco.

Ms. Reisch explained that this motion was to certify a new class of plaintiffs in Dukes vs. Wal-Mart. The new proposed class includes women at Wal-Mart and Sam's Club stores who allege that

## WOMEN AND GIRLS ARE IN THE NEWS--A MESSAGE FROM VALARIE BURGESS S2S IN MORAGA SCHOOLS

Sister-to-Sister's new program will be launched in the fall at the request of the Moraga School District in partnership with the PTA. Girls will be invited to an after-school program to learn communication skills and ways to deal with conflict, to question cultural stereotypes and media messages, and to choose cooperation over competition. S2S high school facilitators will work to broaden the mentoring opportunities that S2S offers. The curriculum will be based on the Girls' Leadership Training attended by Laura and Valarie Burgess last fall in Boston. More help is needed to make this program viable and successful.
